6. Canvass returns for the April 07, 2026 Board of Education General Election for the following technology center for which Cleveland County is an affected county:
  - Mid-America Tech Center (TC-08)– Board Member, Office No. 2
7. Canvass returns for the April 07, 2026 Municipal Runoff Election for the following home rule charter municipality totally contained within Cleveland County:
  - City of Norman- Councilmember, Ward No. 5 (Unexpired Term)
8. Canvass returns for the April 07, 2026 Special Elections for the following home rule charter municipalities totally contained within Cleveland County:


- City of Norman- Proposition No. 1 – Proposition No. 5
