To create such a district, proponents<br/>for creating the district must file a petition with<br/>the municipality. The petition must include the<br/>signatures of one hundred percent of all<br/>surface property owners falling within the<br/>district's proposed boundaries. The<br/>municipality possesses the right to impose<br/>limitations on the district's powers prior to<br/>approving the district. Once approved, the<br/>district will be governed by a board of trustees.</div> <div>Through the board, the district may issue<br/>bonds to pay for all or part of all public<br/>improvements implemented by and for the<br/>public infrastructure district. The district will be<br/>limited to issuing bonds issued for such<br/>improvements not exceeding ten (10) mills. For<br/>repayment of the bonds, the district, acting<br/>through its board of trustees, will levy and<br/>assess a special assessment on all property<br/>benefiting from the improvements in the<br/>district.
