PROPOSITION NO. 1 STREETS

Shall The City of Oklahoma City, State of Oklahoma, incur an indebtedness by issuing registered bonds in the sum of One Billion, Three Hundred Fifty Million, Seventy Thousand Dollars (\$1,350,070,000) to provide funds for the purpose of constructing, reconstructing, improving, rehabilitating, repairing and providing streets, sidewalks, street and pedestrian enhancement improvements and related technology and drainage improvements, along with street maintenance and construction equipment, materials and facilities, to be completed with or without the use of other funds, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to be competitively sold and bear interest at the lowest rate not to exceed ten percent (10%) per annum, payable semi-annually, and to become due serially within twenty-five years from their date?

PROPOSITION NO. 2 BRIDGES

Shall The City of Oklahoma City, State of Oklahoma, incur an indebtedness by issuing registered bonds in the sum of Ninety Million, Five Hundred Ninety-Five Thousand Dollars (\$90,595,000) to provide funds for the purpose of replacing, constructing, improving, rehabilitating, repairing and providing bridges, along with related bridge facilities, equipment, signage, materials and technology improvements, to be completed with or without the use of other funds, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to be competitively sold and bear interest at the lowest rate not to exceed ten percent (10%) per annum, and to become due serially within twenty-five years from their date?

PROPOSITION NO. 3 TRAFFIC SYSTEM

Shall The City of Oklahoma City, State of Oklahoma, incur an indebtedness by issuing registered bonds in the sum of Eighty One Million. Thirty Thousand Dollars (\$81,030,000) to provide funds for the purpose of constructing, installing, acquiring, improving, repairing and providing intersections, turning lanes, traffic signals, traffic system equipment and facilities, along with traffic control maintenance equipment, materials and technology improvements, to be owned exclusively by said City, to be completed with or without the use of other funds, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to be competitively sold and bear interest at the lowest rate not to exceed ten percent (10%) per annum, payable semi-annually, and to become due serially within twenty-five years from their date?

PROPOSITION NO. 4 CITY MAINTENANCE, DATA AND MUNICIPAL SERVICES SUPPORT FACILITIES

Shall The City of Oklahoma City, State of Oklahoma, incur an indebtedness by issuing registered bonds in the sum of Forty Seven Million, Seventy Thousand Dollars (\$47,070,000) to provide funds for renovating, repairing, providing, improving, furnishing, equipping and technology improvements for City maintenance, data and municipal services support facilities at S.W. 15th St. and S. Portland Ave., 100 and 200 N. Walker Ave. and 420 W. Main St, to be owned exclusively by said City, to be completed with or without the use of other funds, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to be competitively sold and bear interest at the lowest rate not to exceed ten percent (10%) per annum, payable semi-annually, and to become due serially within twenty-five years from their date?

PROPOSITION NO. 5 ECONOMIC AND COMMUNITY DEVELOPMENT

Shall The City of Oklahoma City, State of Oklahoma, incur an indebtedness by issuing registered bonds in the sum of One Hundred Seventy-Five Million Dollars (\$175,000,000) to provide funds for the purpose of economic and community development benefitting Oklahoma City, including job creation, housing, and economic and community development programs, with or without the use of other funds, and levy and collect a special tax, payable annually in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to be competitively sold and bear interest at the lowest rate not to exceed ten percent (10%) per annum, payable semi-annually, and to become due within thirty years from their date: Provided however, that in no event shall the real and personal taxable property in said City be subject to a special tax in excess of five mills on the dollar for all bonds issued pursuant to Section 35, Article X of the Oklahoma Constitution?

Shall The City of Oklahoma City, State of Oklahoma, incur an indebtedness by issuing registered bonds in the sum of Four Hundred Fourteen Million, Two Hundred Ninety-Five Thousand Dollars (\$414,295,000) to provide funds for the purpose of constructing, expanding, repairing, improving, renovating, replacing, acquiring, providing, equipping and furnishing parks and recreational facilities, including national and international sporting event facilities, and related maintenance facilities and technology improvements, to be owned exclusively by said City, to be completed with or without the use of other funds, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said City sufficient to pay the interest on said bonds as it falls due, and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to be competitively sold and bear interest at the lowest rate not to exceed ten percent (10%) per annum, and to become due serially within twenty-five years from their date?
